Please note that during NRHA European Futurity, the following rules must be adhered to at all times and by all people

- Your registration for the show with the registration form attached must arrive at the office at least six weeks before the show; the fee for your booth including plus extra charges have to be paid (transfer) upon receiving the invoice and not later than 3 weeks before the show.
- If registration and payment are still due after this time, the price has to be increased by 15 %. If the invoice is not paid before the show starts, Eventomania UG will withdraw from the contract. There will be no extra time given. Besides transferring the money, payment can be made by direct debit. Please sign the release form attached for this.
- As long as the show runs, all booths must be open permanently from 9. a.m. until 6 p.m.
- Delivery to as well as driving into the exhibition area is only possible between 8 p.m. and 9 a.m.
- The erection of your booth should be finished by 8 a.m. on the first day of the event as mentioned above. The booth must not be removed before 7.p.m. on the last day of the event as mentioned above.
- Vehicles (including those used for Camping) may be marked only at the parking spaced for trailers and visitors, not at the exhibition area, close to it or in entrances or exits of it. Emergency and evacuation routes as well as those used for fire brigades must not be blocked at any time

- Please take care of your power connection yourself from the distribution board of EWS Freizeit to your booth. Please use only certified power cables and make sure that they are in proper condition. The same applies to illumination and heating of your booth. Eventomania UG cannot be held liable for any damage here.
- Erecting your booth, please make sure that you do not block any emergency exits, escape or evacuation routes. Otherwise, the exhibitor will be held liable for this.
- Exhibitors must exactly stick to the space reserved. If more space is used, costs for extra square metres will be charged. Booth spaces will be given separately by Eventomania UG for each show. No demands can be made for staying at the same place.
- The booth has to be removed completely after each show, and the space of the booth has to be cleaned afterwards. If this is not done, the exhibitor will be charged the costs for cleaning and repair of any damages.
- Exhibitors are liable for any damage to their property or to property of third persons, resulting from the presence of the exhibitor at Gut Matheshof. Eventomania UG will remain free of any claims.
- After registration and receipt of invoice, the space of booth cannot be reduced any more nor can the power connections be cancelled
- If you cancel your presence completely, the following fees will have to be paid:
 - up to 4 weeks before the show 25 % of invoice
 - up to 2 weeks before show 50 % of invoice
 - 1 week before show: 75 % of the invoice
